I understand that I will furnish my own table(s), **(limit (2))**, chairs, electricity, tent(s) or any other supplies or materials needed for setup.

**I understand that I may vend Foods. However, I MUST CALL the Town Hall to avoid duplication of food.**

I understand that I will vend only new or homemade items. **No used or flea market items permitted.**

I understand that the Town of Awendaw will not be responsible for any costs associated with participating in the Blue Crab Festival.

4. No flea market items may be sold.
5. ***NO ALCOHOLIC*** beverages will be permitted in any of the booths.
6. The Town of Awendaw will ***NOT*** provide: Chairs, tables, tents or electricity.
7. Spaces will be assigned by the Vendor Committee.
8. ***NO PETS allowed except for Seeing Eye or Special Needs Dogs.***
